Visitor + Member Comments

-- George Athas and Rob Sundberg gave an update to on the Novato Birthday: Paint the Town Red event. The event was a huge success, sold out with a waiting list. Compliments were given to Hilary Kinney for her role in planning.

Rock the Block Schedule & Participation

Stephanie Koehler and Rob Sundberg let everyone know Rock The Block 2019 will be held June 20 and September 12. They expressed the importance of the board stepping up to help with sponsorship because WBE will not be sponsoring the \$5,000 for June 20 due to a scheduling conflict on their part. They will be sponsoring the September 12 event. Kiosk is on board for \$5,000 per event and we have tentative smaller commitments from Bank of Marin, Hennessy Funds, and Andalou Naturals.

Novato Theater Discussion

Steve Jordan led the conversation – looking for feedback from the DNBA Membership about the Novato Theater project. The BID Advisory Board is set to discuss it at their next meeting and offer a letter of support for the project. There was overwhelming support for the Novato Theater amongst the membership siting the positive impact it would have on traffic downtown businesses and the vibrancy of downtown as a whole. Andy Podshadly expressed dismay that Councilman Eric Lucan cannot vote on the project. Andy also indicated that the Theater plans to charge a fee to use the multi use space – which people thought was reasonable and prudent. Steve reminded the membership that one of the objectives of the BID is to "combat blight" and therefore he felt it was important to support the completion of the project – so there would no longer be a "hole" in such a key location in downtown.

Minimum Wage Hike Proposal

Steve Jordan led the conversation – looking for feedback from the DNBA Membership about the proposal set forth by several City Council Members (siting the article in the Marin IJ on January 17, 2019) to speed up the proposed mandated minimum wage hike in Novato. Peter, Stephanie and Steve indicated the issue was being brought to membership because of the number of concerned phone calls they had received in the days
